Tribute to

Late Rev. Bro. Octavian - Age 81 years
(10.03.1939 – 19.06.2020)

Former Warden, Teacher, Director & Headmaster from 1962 to 1978.
St. Louis Institute for the Deaf & the Blind, Adyar, Chennai.

Our beloved Bro. Octavian passed away on 19.6.2020 while he was at his age of 81. He died after a brief illness. Unfortunately due to all India Covid lockdown many of our members, families and friends could not attend the funeral of Bro. Octavian held at Tindivanam near Chennai. However a group of Brothers proceeded from Chennai to Montform Brothers of St. Gabriel Church, Tindivanam where the Tomb of Bro. Octavian is located.

St. Louis Institute for the Deaf and the Blind was inaugurated as a new school at Adyar, in Chennai during 1962. Bro. Octavian was first warden of the Deaf Section. He was a good teacher to know well in sign language to Deaf Children for 17 years. There were many Brothers, Sisters & Teachers to support him to help Deaf & Blind boys for improving good education and sports. He was promoted as Director & Headmaster in 1969. He was good social worker for Deaf and Blind in the school, simultaneously The St. Louis Institute of Printing was opened in the same premises for the benefit of. He was the head for priority section as well instrumental in motivating.

Bro. Octavian was aim Deaf students to play sports. The St. Louis school was affiliated to the South Madras (Chennai) Athletic Association and many deaf students were participating in the sports to take matches in Athletic and games with the other schools of the District. This was a turning point in first history of the St. Louis Institute when Deaf students won to get

many awards and Trophies in the events of Athletics, Football, Basketball, Volley ball and Table Tennis. St. Louis Deaf sportsmen were representing in National level sports Championship for the Deaf in India and others sports meet in the states and India. Also they were selected to represent in World Sports Deaflympics. He helped deaf sportsmen to get a job in Dunlop, Ambattur, Chennai in first time.

It was also when Bro. Octavian was there that the first batch of deaf students appeared in the S.S.L.C. Examination. Now the school are increased to open to Deaf Students in Higher Secondary (10+2) and College (B.Com, B.C.A. & M.Com). Many former students got good job in Banks, Govt of India, Govt of states in India and companies after finishing education in St. Louis school. All students are bright to learn good in communication using sign language.

Bro. Octavian settled in Pallavaram house near Chennai Airport in 1983 after his retirement. He was Director of St. Louis Orchestra for the Blind in Pallavaram House, Chennai from 1983 till his death in June 2020. He helped both of Blind women and men persons to work as composer in music and songs in St. Louis Orchestra. He built quarters for Blind persons to stay in same place in Pallavaram house, Chennai.

Our Members invited Bro. Octavian was chief guest to inaugurate New St. Louis Deaf Alumni Association to start on 1st May 2012. Late Bro. Patrick, former Director, St. Louis Institute for the Deaf & the Blind, former teachers and old students came to attend SLDAA's ceremony at World University Centre, Spur Tank Road, Chetpet, Chennai. Again Bro. Octavian was great overjoyed to meet old students during 50th Golden Jubilee Anniversary at St. Louis Institute for the Deaf & the Blind, Adyar, Chennai on 12th September 2012. He was last time to see our members in SLDAA's 6th General Body Meetings & conference on 29th July 2018 at St. Louis Auditorium, Adyar, Chennai (before his death)

He was proud that St. Louis Institute will appreciate the tremendous efforts made by various Directors, Headmasters, Brothers, Teachers and others who worked as one family for the welfare of the differently abled deaf and Blind.
